By enrolling, you understand that all terms and conditions of our Digital Service Agreement and [Terms and Conditions of Your Deposit Accounts](#) apply and remain in full force and effect. Any of these documents may be altered or amended from time to time. When that happens, we'll notify you with an email or letter. Any use of the Online Documents Service after we notify you about such changes will constitute your acceptance of them. Further, we may from time to time revise, modify or update this Online Documents Service Agreement and/or related materials. These revisions, modifications or updates will take effect when we notify you thereof and may render all prior versions of this Agreement and/or related materials obsolete.

We won't send you paper statements, tax forms, most notices or images of your checks after you register for the Online Documents Service. At your request, we'll provide you with a paper replacement copy of your statement only (no check images). Refer to Account Statements in Lake City Bank's [Administrative Charges](#) for the current paper statement fee. You can access check images in your transaction history in Lake City Bank Digital.

Please allow up to three business days for your enrollment to take effect. Depending on your statement closing date, you may receive one more paper statement and may be charged a paper statement fee. As a Lake City Bank Digital user, you're ready to view and download electronic documents. You must have internet and email access, a recent version of a modern browser (Microsoft Edge, Mozilla Firefox, Google Chrome or Safari), an updated version of Adobe's Acrobat Reader software to view documents and a printer if you want a paper copy for your records. If you're using an unsupported browser version, you won't be able to use lakecitybank.com to get to Lake City Bank Digital. Get the most recent version of these browsers at browsehappy.com. You can download a free version of Adobe Acrobat Reader at adobe.com.

You're responsible for the installation, maintenance and operation of your devices and providing us with your current email address. We won't use or provide your email address to third parties for any other purpose without your permission. We'll notify you when your electronic documents are available by email at the address you provided when enrolling for this service. If we can't deliver the notification to your email address, you'll still have access to the documents in Lake City Bank Digital.

You may cancel the service at any time by changing your document delivery method in Lake City Bank Digital.
